DESIGN AGREEMENT

- 1. Timeline** The design package you choose (customized or otherwise), the information you provide, and your acknowledgement of these terms and conditions constitutes a contract. If you have any questions or concerns, please contact us to discuss.
- When we have all the information needed to complete your design package, you will receive your design package by email within 10 business days. We will notify you promptly if we need any additional information from you.
- 2. Renderings** The renderings are meant to be provided as a guide for you to construct and arrange your new space. The paint colors you see are directly representative of the recommended paint color. However, as the actual colors you see will depend on your monitor, we cannot guarantee that your monitor's display of any color will be accurate.
- Upon payment in full by customer to Insigned Designs, LLC, the customer shall be assigned all the renderings, drawings, and all other visual presentations created by Insigned Designs, LLC for the Customer. However, Insigned Designs, LLC is hereby given a perpetual, worldwide, royalty free license to demonstrate and use the work product to market and promote the business of Insigned Designs, LLC. In addition, Customer may not use the Work Product for commercial purposes.
- 3. Limitation of Damages** To the extent that this Site provides links to outside services and resources, the availability and content of which Insigned Designs, LLC does not control. Any concerns regarding any such service or resource, or any link thereto, should be directed to the particular outside service or resource.
- Should any dispute arise under this agreement, both parties agree and consent to Dane County, Wisconsin as the venue for resolution of all disputes and the application of Wisconsin state law as the only law to be so applied. The prevailing party shall be paid its legal costs and attorney's fees by the non-prevailing party. The damages of Insigned Designs, LLC arising out of this agreement shall not exceed the amount paid by the customer to Insigned Designs, LLC.
- 4. Payment** All clients shall pay Designer at least at the rate of One Thousand Five Hundred Dollars (US \$1,250.00) per Basic Package. A 50% deposit of this amount must be received before any design work will commence.
- Designer shall submit final invoice to Client via separate email upon completion of the design package. If Client has chosen any customization options as outlined above, the associated additional cost(s) will be included on the final invoice. They will be listed as separate line items and will clearly describe the Services performed.
- Client shall pay Designer within seven (7) days of receipt of invoice. Designer may suspend performance of any Services if Client fails to pay any invoice when due. Client shall be liable for all costs, fees and expenses (including attorneys' fees) incurred by Designer to collect any amount due. If, after fifteen (15) days, Client fails to pay any outstanding invoice in full, Designer shall be entitled interest in an amount equal to 1.5% per month of the outstanding balance until such invoice amount is paid in full.
